Failure of the respondents to protect hills which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District and violation of the judgment passed by the Hon'ble High Court Division to protect hills of Chittagong area.

GROUNDS

I. For that disregard to laws and legal provisions and failure to ensure proper implementation of laws the respondents have caused enough damage to the environment and the country is adversely affecting. Under these circumstances the respondents are legally bound to protect the hills which is under the control of Korean EPZ at

Karnafuli Thana under Anwara Upazial of Chittagong District in accordance with law.

- II. For that the duty and responsibility vested upon the respondents to serve the people and initiate lawful steps and they are also duty bound to obey the provisions of law. But the respondents have failed to perform the duties and responsibility as vested upon them and by way of violating the provision of law hills cutting are continuing in the Chittagong, which is illegal. Hence a direction may be given upon the respondents to stop hills cutting which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District.
- III. For that the environment is being continuously endangered and threatened by various illegal activities such as cutting hills in the Chittagong area. The unauthorized activities are the main causes for environmental degradation. Taking advantage of the silence of the concern authority, the illegal activities is continuing and as a result the environmental is destroying.
- IV. For that such disregard to laws and legal provisions and failure to ensure proper implementation of laws have caused enough damage to the environment of the area and adversely affecting the environment of the country and as such the respondents are required to be directed to protect the hills which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District, in accordance with law.

Wherefore, it is most humbly prayed that your Lordships would graciously be pleased to:-

- a) A Rule Nisi calling upon the Respondents to show cause as to why inaction of the respondents to protect the hills which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District ,should not be declared illegal and without lawful authority and Why a direction should not be given upon the respondents to stop hill cutting which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District.
- b) Pending hearing of the Rule directs the respondent No. 6-9 to arrange continuous monitoring in the hill area which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong

District, so that no one can destroy/cut/damage the hill.

- c) Pending hearing of the rule directs the respondent no. 6-9 to take legal steps who are cutting hills which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District and file case against them in accordance with law and submit a progress report before this court through Registrar.
- d) Pending hearing of the rule direct the respondent no. 10-13 to take appropriate steps to fill up the soil of the hill which is under the control of Korean EPZ at Karnafuli Thana under Anwara Upazial of Chittagong District within 6 months and file a compliance report before this court.
- e) Pending hearing of the rule direct the respondents no. 10-13 to appear in person on 23.04.2012 at 10.30 am before this Hon'ble Court to explain their conduct.

Present Status:

The case was filled and moved by Advocate Manzill Murshid, President, HRPB. After hearing the parties the Hon'ble High Court Division issued Rule Nisi and statuesque order upon the respondents. The case is pending before the Court
