# IN THE MATTER OF:

To stop earth filling, making permanent structures and encroachment within the area of Pond/(দীঘি) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation, violating the provisions of law and directed the authority to protect the same Pond/(দীঘি) to its original territory as per record.

# GROUNDS-

I. For that the duty and responsibility vested upon the respondents to serve the people and initiate lawful steps and they are also duty bound to obey the provisions of law. But the respondents have failed to perform the duties and responsibility as vested upon them and by way of violating the provision of law the earth filling/encroaching is

continuing within the Pond/(দীঘি) situated at situated at Tajhat area, Kotwali Thana, Rangpur City Corporation Rangpur City Corporation, which is illegal. Hence, direction may be given upon the respondents to stop encroachment and earth filling and pollution of the pond and to protect Pond/(দীঘি) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation to it's original territory as per record.

- II. For that disregard to laws and legal provisions and failure to ensure proper implementation of laws the respondents have caused enough damage to the environment and the local people are being adversely affected in context of right to life. Under these circumstances the respondents are legally bound to protect the Pond/(দীঘি) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation in accordance with law.
- III. For that under Section 5 of the মহানগরী, বিভাগীয় শহর ও জেলা শহরের পৌর এলাকাসহ দেশের সকল পৌর এলাকার খেলার মাঠ উন্মুক্ত স্থান, উদ্যান এবং প্রাকৃতিক জলাধার সংরক্ষন আইন, 2000, also prohibits change of the nature of any land that has been earmarked as a natural reservoir. As per section 8 of the Act 2000 any person who acts in contravention of the Act is liable to imprisonment not exceeding 5 years or a fine not exceeding Taka 50,000 or both. In spite of that provision of law the respondents are not taking any steps in case of killing of Pond, Situated within Rangpur City Corporation. Hence a direction may be given to stop earth filling/encroachment and pollution of the Pond/(দীঘি) situated in Rangpur City Corporation and to protect the same to its original territory as per record.

Wherefore, it is most humbly prayed that your Lordships would graciously be pleased to:-

a) Issue a Rule Nisi calling upon the Respondents to show cause as to why inaction/failure of the respondents to take effective steps to protect the Pond/(দীঘ) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation and to stop encroachment and earth filling of the said Pond, should not be declared illegal and without lawful authority and why a direction should not be given upon the respondents to stop earth filling and encroachment within the Pond/(দীঘ) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation.

Why a direction should not be given upon the respondents to evict/demolish the construction made within the area of pond situated at Tajhat area, Kotwali Thana, Rangpur City Corporation and to protect the said Pond/(नीचि) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation, to its original territory as per record.

- b) Pending hearing of the rule direct the respondent no. 4-10 to take immediate steps within 72 hours to stop encroachment/earth filling/any kinds of construction within the area of Pond/(দীঘি) situated at Tajhat area, Kotwali Thana, Rangpur City Corporation (as reported in Bangladesh Protidin dated 28.06.2016) and file a compliance report within 2 weeks through affidavit before the court.
- c) Pending hearing of the rule directs the respondent no. 8 to submit a copy of C.S, R.S Porcha and Noksha before this court within 30 days through Registrar of the High Court Division, Supreme Court of Bangladesh.

# **Present Status:**

The case was filled and moved by Advocate Manzill Murshid, President, HRPB. After hearing the parties the Hon'ble High Court Division issued Rule Nisi and statuesque order upon the respondents. The case is pending before the Court
