# Quazi Reza-Ul Hoque, J:

The respondent No. 10 files compliance as per direction of this Court (annexure-2), wherein it is stated that in connection with grabbing Government land and filling up pond Sonargaon P.S. Case No. 36 dated 12.11.2014 has been filed under section 447/431/427/114/506 of the Penal Code and two accused were arrested and the concerned land in question now is in total control of the Government, as such, we direct the Local Government Authority, i.e. the respondents to be more vigilant and take necessary actions, if any, if such occurrence happen again.

The respondents are further directed to keep control of such khas land of the Government in accordance with law.

With the above observations the Rule is disposed of.
